REUTERS/Lim Huey Tzu Mahathir told reporters he would consider a request by his deputy, Datuk Seri Mohamed Nazri Abdul Aziz, to sack him from his post as finance minister. Nazri said the government wants to exercise "political judgment" and to revive the debate on Friday on whether to bring back Najib Razak to parliament after he resigned as prime minister and deputy prime minister last month. Najib has been accused of corruption and facing billions of dollars in debts related to a scandal over state fund 1Malaysia Development Berhad (1MDB). He denies any wrongdoing. Following the 2.2 million-signature "Tun Razak Exchange" petition and Nazri's comments, Mahathir said he had started work as the prime minister on the same day as the resignation of Najib, on April 2, 2018. "I became the prime minister of this country on that day. I was engaged on that day. I have no problem in attending the parliament. The question, now, is whether I am involved in the Nizam's business or not. If I am, that would be a problem," Mahathir told a news conference. The Nizam's reference is to Najib, who is the only son of the former sultan of the southern state of Negeri Sembilan. Najib has been accused of being close to the Nizam. Mahathir said Nazri would take over as prime minister in his absence, adding that he would consult with him before deciding whether or not to return to parliament. Mahathir has said he is determined to check allegations that Najib was involved in the disappearance e79caf774b
